## About this course

This course specifies requirements to develop, implement, operate, monitor and provide a documented integrated Facility Management - Management System (FMMS) within the context of the new ISO 41001: 2018 standard. It covers typical examples, proven practices and strategic options for use. It also explores how FMMS can be applied to both internal and external service delivery of facility management.

In Hong Kong, Property Management Services Ordinance (Cap. 626) stipulates that the criteria for holding a property management practitioner (PMP) license may include criteria relating to an applicant's academic qualifications, relevant work experience and professional qualifications. This course also introduces the route to becoming a PMP license holder and the criteria to hold the PMP license.
